AN ENVIRONMENTAL HEALTH PERMIT APPROVED BY A REPRESENTATIVE OF THIS DEPARTMENT IS REQUIRED BEFORE OPERATING A NEW OR CLOSED FOOD FACILITY. YOU ARE NOT AUTHORIZED TO OPERATE UNTIL ALL APPROVALS HAVE BEEN OBTAINED. IN THE EVENT THE PERMIT IS NOT APPLIED FOR OR NOT RENEWED WITHIN THIRTY (30) DAYS OF THE DATE OF PERMIT EXPIRATION, AN ADDITIONAL PENALTY FEE OF 20% WILL BE REQUIRED. IF THE PERMIT IS NOT APPLIED FOR OR NOT RENEWED WITHIN SIXTY (60) DAYS OF THE DATE OF THE PERMIT EXPIRATION, AN ADDITIONAL PENALTY OF 100% WILL BE REQUIRED. I HEREBY APPLY FOR A RECEIPT/PERMIT, WITH APPROPRIATE FEES ATTACHED, TO OPERATE THE ABOVE INDICATED NON-PERMANENT FOOD FACILITY.

## MFF PERMIT CHECKLIST

The following information must be provided annually for mobile food facilities, as indicated, before a permit will be issued:

- Commissary agreement letter (permit category 2-5)
- Commissary schedule (permit category 2-5)
- Written operational procedures (permit category 4, 5)
- Menu/listing of all foods offered from mobile food facility (permit category 4, 5)
- Route sheet or proof of other Department approved reporting/tracking method (permit category 4, 5) Other: \_\_\_\_\_
- Food Manager/Food Handler Certificates \_\_\_\_\_ (permit category 4, 5)

- Restroom agreement letter for any selling locations facility is at for longer than 1 hour (permit category 5)
