## FOOD SAFETY MANAGER CERTIFICATION

Under the California Retail Food Code, each food facilities handling *non-prepackaged potentially hazardous foods* is required to have at least one certified Food Safety Manager. This individual may be an owner or employee who has passed one of several recognized examinations (see the reverse of this sheet for a list of certified exam companies).

- The Riverside County Food Worker's Certification, required of *all* food workers, does not satisfy this requirement.
- Individuals who successfully pass an accredited food safety certification exam **ARE NOT** required to additionally obtain Riverside County's Food Worker's Certification.
- One person *cannot* satisfy this requirement for more than one facility, although multiple facilities directly next to each other at the same location and under the same ownership are recognized as one entity and will need only one certified food safety manager.
- The certified food safety manager must be employed by the facility, but they need not be present at all times. The certified food safety manager must train food service employees in basic food safety principles. Evidence of certification must be kept on-site at all times for review by inspectors.
- New operations and facilities that lose their certified food safety manager will have 60 days to comply with this requirement.

Each restaurant, grocery store, convenience store, delicatessen, school cafeteria, refreshment stand, commissary and mobile food facility that prepares or serves non-prepackaged potentially hazardous food must have a certified food safety manager. Facilities that handle non-prepackaged non-potentially hazardous foods may take either the exam or show adequate food safety knowledge pursuant to the types of foods handled.

Facilities exempt from this requirement include:

- Temporary food booths
- Farmer's markets
- Produce stands selling only *uncut* produce
- Any food facility handling only *prepackaged* food
