It is your responsibility to ensure that these clearances are secured. The utility clearances correspond with Section C, "Utilities" on the Application for Review of Food Establishment Construction/Remodel Plans form which you signed and submitted with your plans. Even if your project does not require a grease interceptor, an exemption letter from the Industrial Waste Section/Source Control Division is still required. It is your responsibility to secure the utilities for your project and provide this Department with the correct information for plan check processing.

It is imperative that the timely receipt of these clearance letters occurs so as to not impede the ultimate release of your plans to you.

Individuals submitting plans to this Department for the "Remodel of an Existing Food Establishment" need only to submit the clearance letter from the Industrial Waste District (Grease Interceptor).
